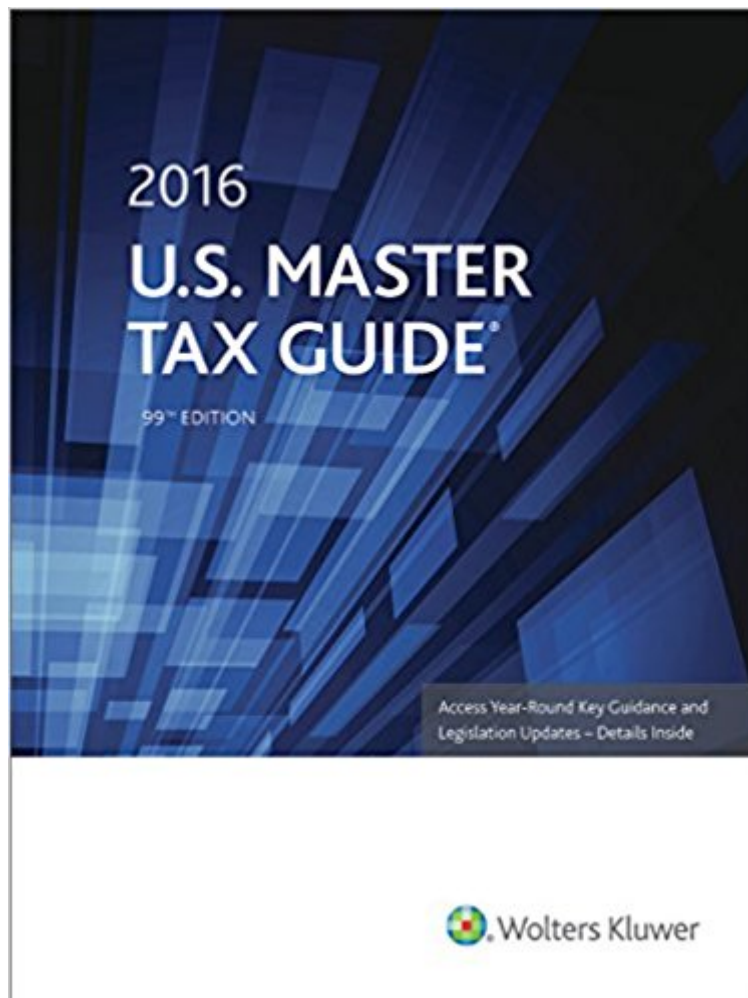

It is surprising but again, there is so much tax information jammed packed into this book, I'm actually surprised that more hasn't been left out.
