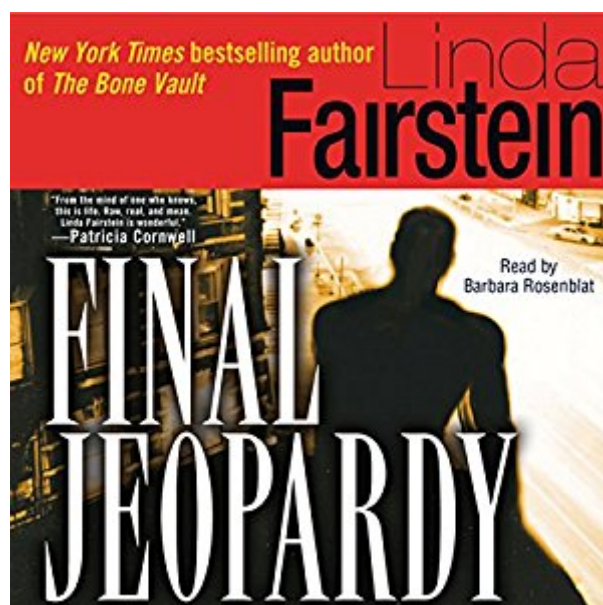

Thought I'd give this author a try after hearing her speak on a morning show...BIG disappointment for me. Found it, as usual, filled with predictable characters, run of the mill, wordy, ridiculous and downright unbelievable, gibberish. The female character is more interested in telling the reader the designer of each and every piece of clothing she is wearing (the costume changes are numerous and boring) and how she is able to luxuriate in the rich and famous lifestyle, whilst being incredibly committed to being a public prosecutor of sexual crimes. Seriously??? Not even a 'fun' read in my estimation. When I find myself skimming two or three pages - to pick back up on the storyline, I know I have wasted my money and time. Probably the last book I will buy by a female author, because I have not found one yet that doesn't disappoint. (except for Janet Evanovich) two or three years ago with one of her quirky series that were AT LEAST fun to read.

I found a later book in this series in a library, and enjoyed it so much that I've started on the entire series. The details in Fairstein's books seem to be very accurate (at least to a layman in the investigative and prosecution fields), and the characters are well-developed and engaging. As has

been noted by other reviewers, the ebook version contains a number of typos, mostly typical of books that are converted from print to ebook by OCR with little or no proofreading (for example, the name of one character, "Jed," often appears as "led"). This book was copyrighted in 1996 so this is likely what happened, but if a book is good enough to republish as an ebook and sell for more than a nominal price, it should be worth proofreading, and an author who has pride in his or her work should insist on it! (I have started reading Likely to Die, second in the series, and so far it seems to have been proofread much better.) Some readers may be troubled by the sex-crime aspect of the plots, based on Fairstein's actual experiences with the Manhattan DA's office, but this is well worth a read by anyone else who enjoys technically-accurate mysteries.

This book gives great information on the workings of the New York prosecutors and the law enforcement officials they work with. Alex Cooper, however, is a little more difficult to relate to. Because she is rich and beautiful, I would have found her more appealing if she had struggled a little more, in some aspect of her life. The plotting, though, is really good and the ancillary characters are well drawn. I will continue to read the books in this series.

I thought the book was very well put together and the ending was extremely well crafted. My only hang up was the many times that words were misspelled, especially the name of a principal character, (Jed was very frequently spelled Led). Overall, I liked the book and intend to read others by this author.
