

Calling all theology nerds: Keep an eye on this author. This scholar is up and coming. As far as I can tell, his name hasn't hit the veritable vernacular of wanna-be scholars like myself but it's only now a matter of time. With endorsements from Vanhoozer and the Foreword by Bartholomew, the big-timers are already talking. After reading his previous book, *The Love of God: A Canonical Model* I was floored hook, line and sinker and I immediately set my sights on his latest work, which is this one. It just came out a few days ago and I'm not

ashamed to say that IÃ¢Â™ve finished it already! :)PeckhamÃ¢Â™s work is in my mind, one of a kind. Not just for the included information (think Ã¢Âœerudite to the maxÃ¢Â•). But more so, it's his PROCESS which is so illuminating. I've found the results of his work to show such originality that IÃ¢Â™m all but obliged to prod behind-the-scenes to see what's going on. In the last chapter of the book, Peckham lays this process out for all to see, which he is calling, the Ã¢ÂœCanonical Model.Ã¢Â• Briefly summarized, PeckhamÃ¢Â™s process is the following:1) Identify the issues and engage the ongoing scholarly conversation by way of a careful literature review of theological perspectivesÃ¢Â|so as to highlight crucial theological questions at the center of the conflict. [In his footnote, Ã¢Âœit is crucial first to read to understand and only thereafter to critically analyze the secondary materialÃ¢Â• (p247)]2) Then conduct an inductive reading of the entire canon of Scripture, isolating any texts that even slightly impinged on such issues Ã¢Â“ with care to avoid selecting passages based on predispositions (insofar as is achievable).3) Attempt to then table presuppositions, subjecting them to the test of the canonical data. This requires a commitment to self-examination, self-criticism, and willingness to follow the canonical data wherever it leads.4) The large amount of data is then extracted, analyzed and grouped in an ongoing spiral, which includes both narrowing and expansion of the data when themes become more or less significant than originally thought throughout the ongoing analysis.5) Look for patterns. Do lots and lots of semantic analysis.6) Now, engage sources from a broad spectrum. For example, in his previous book, Peckham engaged major commentary series and selected commentaries from across the spectrum of exegetical approaches (Including but not limited to: Anchor, ICC, Hermeneia, JPS, Word, InterpreterÃ¢Â™s, NICOT/NICNT, NAC as well as standalone volumes and exegetical works on concepts, words, topics, etc.).7) Construct a minimal model from the data (leading to Ã¢Âœmany facts that I would not have anticipated at the outset of my studyÃ¢Â• and to Ã¢Âœother delightful surprisesÃ¢Â• (254) as he wondered what would happen in the end to the Ã¢Âœapparent tensions.Ã¢Â•8) Conclude with a discernible, demonstrable and defensible conception. All the while, seeking to:1) Approach the canon humbly2) Read ethically3) Derive from the canon minimally that which can be held with confidence as discernible, demonstrable and defensible4) Move in a disciplined, delimited fashion from the particulars of divine revelation to universal (metaphysical) conceptions5) Refrain from premature conclusions and overreaching extrapolations by restricting conclusions to minimal sound inferences that are also discernible, demonstrable and defensibleAs stunning as all of this is, one of his last lines was the most exciting:Ã¢ÂœÃ¢ÂœÃ¢Â•My hope is to implement this approach on a number of other topics in the future.Ã¢Â• (page 257) To which I say, YESSS!
